	WITNESSETH THAT:				
	GKI agrees that the Dealer may purchase the products of GKI at prices determined by GKI which are below the retail price,				
	subject to GKI's policies regarding sales, marketing and payment.				
	The Dealer represents and warrants that all the information he/she has given in this Registration Form and Agreement is				
	true and accurate.				
	The Dealer agrees:				
a)	·				
	GKI which are current at the time of sale.				
b)	To abide by Human Nature's ONLINE SELLING guidelines, as follows.				
	 Dealers may sell on Facebook Marketplace, Instagram and other platforms EXCEPT Shopee, Lazada and Tiktok to their local communities without prior approval, but must provide the links to their online shops to their mother branch or GKI Head Office. 				
	ii. Dealers must get prior approval to sell online on national online platforms such as Shopee, Lazada and Tiktok . Approval for these				
	platforms will be given in writing, not verbally.				
	iii. If the Dealers were able to get approval to sell in Shopee, Lazada and Tiktok . Everything must be sold following the regular SRP.				
	Dealers are also not allowed to offer any discounts, cashback or other promos on online platforms such as Shopee, Lazada, Tiktok or				
	any other popular online platform. Only FREE SHIPPING is allowed as a promo offer for online sellers, unless otherwise approved in				
	writing by GKI Head Office in advance. Any dealer found discounting online may have their discount and dealership revoked.				
c)	Dealers cannot use "Human Nature" as the name of their store.				
d)	TO STORE THE PRODUCTS AWAY FROM SUNLIGHT AND BELOW 30 DEGREES CENTIGRADE TO PRESERVE THE				
	QUALITY OF THE PRODUCTS. Failure to do so will cause irreparable damage to the products such as loss of fragrance, separation or				
	discoloration since the products do not contain chemical stabilizers or emulsifiers.				
e)	To maintain a minimum purchase of P2000/month net of dealer discount in order to continuously avail of discounts.				
f)	Not to sell GKI's products in or to retail stores, or any other fixed places of business without prior written permission from GKI.				
g)	Not to sell GKI's products to customers outside the Philippines without prior written permission from GKI. International deliveries require				
	documents and permits that can only be provided by GKI, and are subject to import regulations specific to each country.				
	To never leave the products in the vehicle or any other place that may be subject to heat, and to accept liability for any change in the quality				
:\	of products not properly stored in accordance with these directions.				
i)	Not to allow anyone to use his/her Dealer ID to purchase at a discount. Only the registered dealers may use the Dealer ID. (Representatives may collect items on behalf of the Dealer if they are the registered ATP or authorized person to purchase.)

- That this Agreement does not confer authority to the Dealer to use any of the trademarks or trade names owned by GKI. c)
- That the Dealer will abide by all policies of GKI which may change from time to time without prior notice. d)
- That GKI may change its prices, commission, incentive and credit policies with regard to the Dealer and may reduce or cancel discounts or other benefits without prior notice.
- That either party may terminate this Agreement, with or without due cause, at any time upon notice to the other. Upon termination, all monies f) owed by the Dealer shall become immediately due and payable.
- That in case of dispute arising directly or indirectly from this Agreement, settlement shall be pursued by either Arbitration or through the g) proper courts at the option of GKI.
