

## Independent Member Agreement

This Agreement, made this \_\_\_\_ day of \_\_\_\_\_, year \_\_\_\_ between human  nature-Gandang Kalikasan, Inc (“GKI”) and \_\_\_\_\_ (“Member”) WITNESSETH THAT:

**GKI agrees that** the Member may purchase the products of GKI at prices determined by GKI which are below the retail price, subject to GKI’s policies regarding sales, marketing and payment.

**The Member represents and warrants that** all the information he/she has given in this Application Form and Agreement is true and accurate.

### The Member agrees:

- a) To obtain and maintain all permits and licenses necessary for the continuance of his/her business.
- b) To ensure that he/she complies with all applicable laws governing his/her business, including payment of any and all taxes.
- c) To pay for all his/her purchases in accordance with the payment policies of GKI without the need for GKI to demand payment.
- d) To hold GKI, its officers and employees free and harmless from any claim, expense, liability, suit or demand arising from the conduct of his/her business.
- e) To immediately inform GKI of any change in his/her personal information given in this Application Form.
- f) Not to allow anyone to use his/her Member ID to purchase at a discount. Only the registered member may use the Member ID. (Representatives may collect items on behalf of the Member only with a valid letter of authorization.)
- g) To sell all products bought from GKI only at the suggested retail prices set by GKI which are current at the time of sale.
- h) Not to sell GKI’s products in or to retail stores, supermarkets or other fixed places of business without prior written permission from GKI.
- i) Not to sell GKI’s products to customers outside the Philippines without prior written permission from GKI. International deliveries require documents and permits that can only be provided by GKI, and are subject to import regulations specific to each country.
- j) **TO STORE THE PRODUCTS AWAY FROM SUNLIGHT AND BELOW 35 DEGREES CENTIGRADE TO PRESERVE THE QUALITY OF THE PRODUCTS.** Failure to do so will cause irreparable damage to the products such as loss of fragrance, separation or discoloration since the products do not contain chemical stabilizers or emulsifiers.
- k) To never leave the products in the vehicle or any other place that may be subject to heat, and to accept liability for any change in the quality of products not properly stored in accordance with these directions.
- l) To allow use of his/her name for publication from time to time in company documents, merchandising and other material especially in relation to sales figures and performance tables.
- m) To maintain a minimum average purchase level of P800/month net of member discount in order to continuously avail of discounts.
- n) Immediate family member living in the same address cannot be tagged as a downline.

### GKI and the Member agree:

- a) That this Member Agreement does not make the Member an employee or agent of GKI. The **Member** is an independent business person.
- b) That this Agreement does not give the Member authority to enter into any agreement or contract with any party by representing himself/herself as an employee or agent of GKI or commit GKI to any contract or agreement with any third party.
- c) That this Agreement does not confer authority to the Member to use any of the trademarks or trade names owned by GKI.
- d) That the Member will abide by all policies of GKI which may change from time to time.
- e) That GKI may change its prices, commission, incentive and credit policies with regard to the Member and may reduce or cancel discounts or other benefits without prior notice.
- f) That either party may terminate this Agreement, with or without due cause, at any time upon notice to the other. Upon termination, all monies owed by Member shall become immediately due and payable.
- g) That in case of dispute arising directly or indirectly from this Agreement, settlement shall be pursued by either Arbitration or through the proper courts at the option of GKI.
- h) That this Agreement supersedes any prior agreements between GKI and the Member.
