## Independent Advocate Agreement

This Agreement, made this \_\_\_\_ day of \_\_\_\_\_, year \_\_\_\_\_ between human♥nature -Gandang Kalikasan, Inc (“GKI”) and \_\_\_\_\_ (“Advocate”) WITNESSETH THAT:

**GKI agrees that** the Advocate may purchase the products of GKI at prices determined by GKI which are below the retail price, subject to GKI’s policies regarding sales, marketing and payment.

**The Advocate represents and warrants that** all the information he/she has given in this Application Form and Agreement is true and accurate.

### The Advocate agrees:

- a) **To sell all products bought from GKI ONLY AT THE MAGALOGUE/ HUMAN NATURE BROCHURE PRICES set by GKI which are current at the time of sale.**
- b) **To abide by Human Nature’s ONLINE SELLING guidelines, as follows.**
  - i. Dealers may sell on Facebook Marketplace, Instagram and other platforms to their local communities without prior approval, but must provide the links to their online shops to their mother branch or GKI Head Office.
  - ii. Dealers must get prior approval to sell online on national online platforms such as Shopee and Lazada. Approval for these platforms will be given in writing, not verbally.
  - iii. Everything sold online must be sold following the current Human Nature brochure prices.
  - iv. Sellers may not offer any discounts, cashback or other promos on online platforms such as Shopee, Lazada or any other popular online platform. Only FREE SHIPPING is allowed as a promo offer for online sellers, unless otherwise approved in writing by GKI Head Office in advance. Any dealer found discounting online may have their discount and dealership revoked.
- c) **TO STORE THE PRODUCTS AWAY FROM SUNLIGHT AND BELOW 30 DEGREES CENTIGRADE TO PRESERVE THE QUALITY OF THE PRODUCTS.** Failure to do so will cause irreparable damage to the products such as loss of fragrance, separation or discoloration since the products do not contain chemical stabilizers or emulsifiers.
- d) To maintain a minimum purchase of P800/month net of advocate discount in order to continuously avail of discounts.
- e) Not to sell GKI’s products in or to retail stores, or any other fixed places of business without prior written permission from GKI.
- f) Not to sell GKI’s products to customers outside the Philippines without prior written permission from GKI. International deliveries require documents and permits that can only be provided by GKI, and are subject to import regulations specific to each country.
- g) To never leave the products in the vehicle or any other place that may be subject to heat, and to accept liability for any change in the quality of products not properly stored in accordance with these directions.
- h) Not to allow anyone to use his/her Advocate ID to purchase at a discount. Only the registered advocates may use the Advocate ID. (Representatives may collect items on behalf of the Advocate only with a valid letter of authorization.)
- i) Immediate family member living in the same address cannot be tagged as a downline.
- j) To immediately inform GKI of any change in his/her personal information given in this Application Form.
- k) To hold GKI, its officers and employees free and harmless from any claim, expense, liability, suit or demand arising from the conduct of his/her business.
- l) To allow use of his/her name for publication from time to time in company documents, merchandising and other material especially in relation to sales figures and performance tables.
- m) To obtain and maintain all permits and licenses necessary for the continuance of his/her business.
- n) To ensure that he/she complies with all applicable laws governing his/her business, including payment of any and all taxes.
- o) To pay for all his/her purchases in accordance with the payment policies of GKI without the need for GKI to demand payment.

### GKI and the Advocate agree:

- a) That this Advocate Agreement does not make the Advocate an employee or agent of GKI. The **Advocate** is an independent business person.
- b) That this Agreement does not give the Advocate authority to enter into any agreement or contract with any party by representing himself/herself as an employee or agent of GKI or commit GKI to any contract or agreement with any third party.
- c) That this Agreement does not confer authority to the Advocate to use any of the trademarks or trade names owned by GKI.
- d) That the Advocate will abide by all policies of GKI which may change from time to time without prior notice.
- e) That GKI may change its prices, commission, incentive and credit policies with regard to the Advocate and may reduce or cancel discounts or other benefits without prior notice.
- f) That either party may terminate this Agreement, with or without due cause, at any time upon notice to the other. Upon termination, all monies owed by Advocate shall become immediately due and payable.
- g) That in case of dispute arising directly or indirectly from this Agreement, settlement shall be pursued by either Arbitration or through the proper courts at the option of GKI.
- h) All personal data acquired by GKI from the Advocate shall only be used for the purposes of this Agreement and as required to fulfill services provided by GKI and shall not be further processed or disclosed without the consent of the advocate.
- i) That this Agreement supersedes any prior agreements between GKI and the Advocate.

**NOTE: Advocates who have become Fixed Location Partners or Branch Operators have separate contracts and are not covered by the Human Nature Dealership program, hence upline and referral fees will not be applicable.**
